Nomination Papers for Village President and Trustees can be picked up at the Clerk/Treasurer's office during normal business hours. The completed forms need to be returned on or before January 2nd, 2013.

Winter Parking Restrictions: No person shall park any vehicle on any street or alley in the Village between two-thirty (2:30) AM to six (6) AM of any day from November 1st to April 1st. If you have questions on this, please contact the Reedsville Police Dept at 754-4656.

Payment of Property Taxes: Real estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours. Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. A receipt will only be sent back if you have included a self-addressed stamped envelope. All first installment taxes are due by January 31, 2013. All taxes must be paid by check or money order and made payable to the Village of Reedsville.

There are several types of advance directives, including:

- The Five Wishes® is a Power of Attorney for Health Care document that names a person who can make decisions for you, if you cannot. This person is chosen by you, and named in the document to make certain that your wishes are followed. The document also gives you the opportunity to choose your wishes, and cross out those you do not want by giving clear instructions to follow.
- A Living Will does not name a person to speak for you. Rather, it is a legal document that states your preference for life-support if you are terminally ill or are in a "persistent vegetative state."

If you do not have an advance directive, your health care providers will look to your family or close friends to help make decisions about your care. To order a copy of Five Wishes®, call 1-888-863-5502, or they are available at your clinic site. *Denise Brilliant, NP, is a nurse practitioner at Aurora Health Center in Reedsville. To schedule an appointment, call 920-754-4337.*

CodeRED Alert Notification System

Manitowoc County has a "layered" emergency warning and notification system that includes sirens, pagers, radio and TV station announcements, and NOAA weather radios. In recent months we've purchased a system called CodeRED that will deliver emergency warning information via cell and land line telephone. CodeRED delivers up to 1000 calls per minute. There is no hardware for the general public to buy and no cost to be registered in the database. The calls can be sent out county wide or in limited geographic areas. Our plan initially is to use CodeRED for severe weather alerts, missing children and elderly, health emergencies, nuclear events and selected public information notices, e.g. power outages and road closures. At this time, an initial calling database has been set up on a secure server. The phone numbers in that database are primarily land line phone numbers. If county residents wish to be notified via cell phone, they must manually enter the number(s) on the Manitowoc County website: www.manitowoccounty.com. Click on the CodeRED icon in the upper right hand corner of the home page. It will bring up a page that will allow one to enter cell phone numbers and/or perhaps a work number. The site is secure and the phone numbers will never be made public. If you need assistance entering your number, please call the Emergency Management Office at 683-4207.

Letting others know your health care wishes

If you should become terminally ill or incapacitated, you still have the right to say "yes" or "no" to medical care and treatment options. But what if you became unable to speak for yourself? You should discuss your wishes with your family and health care provider. One way to make your wishes known is to put them in writing through an advance directive, like the Five Wishes® document or Aurora's Power of Attorney for Health Care. Make sure a copy of your completed document is given to your health care provider.

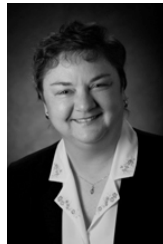

Dear Village of Reedsville Residents;

The Village of Reedsville has contracted with Deyo Disposal, Inc. of Greenleaf, WI to provide your solid waste & single-stream recycling services effective January 1, 2013.

Collection Standards for Trash: Service Day: **FRIDAY**

Please place your gray trash cart at the curb weekly on Friday 6:00am. All solid waste (trash) must be bagged and contained in your cart, with lid closed.

- **Items outside of cart will not be serviced.**
- 1. **Large bulky items:** such as furniture, construction debris, appliances, and or tires. These items are considered a special pick-up. There will be an extra charge, determined by weight and size.

Please contact our customer care staff for extra service pricing and scheduling. Yard waste prohibited (please contact the Village regarding proper disposal site.)

Collection Standards for Single-stream Recycling: EVERY OTHER WEEK

Every other Friday of the month please place your green recycling cart at the curb by 6:00am.

All recyclables must be contained in your cart, with lid closed. (Please contact our office if you will have any overage.) Thank you
Recycling carts placed out on the wrong weeks will not be collected.

**DO NOT PARK OR PLACE CART WITHIN 4FT OF ANY OBJECTS,
TO ASSURE PROPER SERVICE**

SINGLE-STREAM: To mix co-mingle and paper into one container

Placed loosely in green recycling carts (Please do not bag)

Co-Mingled Recyclables Service: Aluminum, Steel Cans, Bi-Metal Cans, Glass and Plastic Containers; #1 PETE & #2 PETE with a small neck open than the base (All containers must be cleaned of all residues.)

Paper/Cardboard Mixed: Loose paper, i.e. magazines, books, junk mail, envelopes, phone books, catalogues, writing paper, news and shredded paper place in paper grocery bags, inside of cart. All cardboard must be cut to fit inside cart.

Holiday Service:

If the collection date shall fall on a holiday, collection shall occur on the Thursday before the holiday.

RECYCLING CARTS PLACED OUT ON THE WRONG WEEKS WILL NOT BE COLLECTED

Holiday Service:

If the collection date shall fall on a holiday, collection shall occur on the Thursday before the holiday.

Single Stream Recycling: Carts should be placed at least 4' apart or on separate sides of your driveway.

The following are items acceptable for single stream recycling and should be put in your green recycle cart.

Glass: Rinsed bottles and jars of any color.

Steel/Aluminum: Rinsed aluminum, steel, bi-metal cans, and non-pesticide aerosol cans.

Plastic: Rinsed containers where the neck of the bottle is smaller than the base or widest part of the container such as soda bottles, milk jugs, laundry bottles, vinegar containers, shampoo, conditioner, etc...

Paper/Cardboard: Clean cardboard and paper such as magazines, books, junk mail, envelopes, phone books, catalogues, writing paper, newspaper, and shredded paper placed in a grocery bag in your recycle cart. All cardboard must be cut to fit into your recycle cart.

The following are items not acceptable for single stream recycling and should be put in your gray solid waste (trash) cart:

- Paper that is contaminated with food grease or debris; Tissue products and foil
- Clay flower pots, ceramic cups and plates; drinking glass and dinner ware; pots, pans and ovenware; styrofoam, and microwave containers
- Light bulbs, window glass and auto glass
- Paint cans with dried sludge or dried paint
- Sheet metal, screws and nails; car parts and small appliances
- Plastic bags, yogurt and cottage cheese type containers, toys
- Motor oil bottles, solvent or chemical containers; empty pesticide and herbicide containers

The minutes of the previous meeting of September 17, 2012 were approved as presented.

A motion was made by Reis and seconded by Rabideau to pay the accounts payable in the amount of \$11,217.06. Motion carried 5-0.

President Report: Olson asked the Board to be courteous and listen to the visitors.

Committee Reports:

Public Safety: Police Dept – Written. A motion was made by Bubolz and seconded by Campana to approve the pay increases as presented for the First Responders effective October 1, 2012. They will be asked to have an officer attend the first meeting of each month. Motion carried 5-0. The discussion on ambulance service was postponed until the next meeting.
