## Notes from the Village Hall

**Effective January 1, 2013:** The Village has contracted with Deyo Disposal Inc. to provide solid waste and single stream recycling services. Please place the trash (grey cart) at the curb by 6:00 am on Fridays. Collection for recycling (green cart) is every other Friday, starting January 4<sup>th</sup>, 2013. If you have not received the two carts, please contact Deyo Disposal at 920-864-5808.

**Payment of Property Taxes:** Real Estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours. Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. A receipt will be sent back only if you have included a self-addressed stamped envelop. All first installment taxes are due by January 31, 2013. The Village appreciates all taxes be paid by check or money order made payable to the Village of Reedsville.

**Cat & Dog Licenses** are due on or before April 1, 2013. Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

**Clerk/Treasurer's Office Hours:** Monday thru Thursday, 8:00 am to 3:00 pm and Friday, 8:00 am to 1:00 pm. **The office will be closed all day December 24<sup>th</sup>, 25<sup>th</sup>, 31<sup>st</sup> and January 1<sup>st</sup> for the holidays.**

**Snow & Ice Removal:** The owner or occupant of any lot abutting on a public sidewalk shall clear their sidewalk of snow within twenty-four (24) hours after a snowfall and keep the same free of ice. If such snow or ice is not removed as required herein, the Street Dept. shall cause the same to be done and the cost thereof assessed against the property owner.

**Nomination Papers** for Village President and Trustees can be picked up at the Clerk/Treasurer's office during normal business hours. The completed forms need to be returned on or before January 2, 2013.

### Utility Bill Payment Services:

You can use your credit/debit card, Amazon Payments or PayPal account to pay your utility bill. The Village of Reedsville has partnered with *Wisconsin Payments* for this service. All payments using this service are done on a PCI compliant network and no information is ever stored on any server. They are located at [www.wisconsinpayments.com](http://www.wisconsinpayments.com). You will need your utility account number each time you make a payment. **OR** You can have your utility payment deducted automatically from your checking or savings account. Forms can be picked up at either the Village Clerk-Treasurer office or the Denmark State Bank – Reedsville.

### Spotlight on COPD

Chronic Obstructive Pulmonary Disease (COPD), also known as emphysema and chronic bronchitis, is a very serious disease, and the third leading cause of death in the United States.

The good news is that COPD is often preventable and treatable.

The most important risk factor for COPD is cigarette smoking. Between 80% and 90% of COPD cases are caused by cigarette smoking.

You are more likely to develop COPD as you get older, but this is partly related to the number of years of cigarette smoking.

A history of frequent childhood lung infections increases your risk of developing COPD. Frequent infections can lead to scarring of lung tissues, which reduces their elasticity and can lead to COPD.

COPD is much more common in men than in women, but this may be largely related to the higher rate of smoking among men.

COPD is also more common in whites, despite high rates of smoking among other racial and ethnic groups. This suggests that genetic factors that increase the risk of COPD may be more common in whites than in other racial and ethnic groups.

Chronic exposure to dust, gases, chemicals, and biomass fuels also increase your risk of developing COPD and can worsen symptoms of the disease.

If you have a number of risk factors for COPD, ask your healthcare provider what you can do to reduce your risk.

## Adopt-A-Hydrant

The winter months bring a special concern to the Reedsville Fire Department. Winter snowfall with the plowing of snow can often hide fire hydrants under a large amount of snow making them difficult to find quickly. In the event of a fire, firefighters have to locate and shovel out fire hydrants before hooking up to them. Precious time is lost. Please don't let your neighborhood fire hydrant remain "undercover".

The hydrants are normally cleaned out by the Village Street Department, but due to budget and time restraints it can go several days before being cleaned out. We are asking that you help protect yourself and your neighbor by "adopting" the fire hydrant closest to your residence or business and keep it clear of snow.

We need a 3 foot clearance on all sides. When shoveling snow please be aware of vehicle traffic. Do not stand in the street and be careful not to slip and fall out into the roadway.

If you notice a hydrant that needs to be cleaned out, and are unable to "adopt" it, please contact the Village Street Department at 754-4371, so they can take care of it.

**Holiday Waste Reduction**

**MINUTES – REGULAR BOARD MEETING**  
**OCTOBER 22, 2012**

The regular meeting of the Reedsville Board of Education was called to order at 6:29 P.M. by Board – President John Ebert. Present: Board Members – Jeff Deprez, Cory Kiekhaefer, and Andrew Maertz; Todd Cavanaugh arrived late. Administrative Team Members - Dennis Raabe, Tony Butturini, Pat Popp, and Tracie Wurm; Others: Becky O’Leary, Sue Punt, Joy Spatchek, Dan Sonnenberg, Kim Luedtke, Stephanie Cariveau, Mary Zastrow , Laurie Town, Lisa Podgorski, Kim Zaudtke, Darlene Propson, Margaret Reichert, Harry Strother, Joe Schmatz, and Jerold Korinek. Media – Justin Cavanaugh, recording.

3<sup>rd</sup> Graders introduced their newspaper, The Connector. They are distributing them to local area businesses. Each issue has a spotlight community member.

Mr. Raabe announced that proper legal notice of the meeting had been given.

3<sup>rd</sup> Graders led everyone in the Pledge of Allegiance to the Flag.

**I. Opening**

**A. Agenda**

The agenda was approved as printed.

Jeff Deprez motioned to move Mr. Butturini’s report up due to his Adult Econ. class. Cory Kiekhaefer seconded the motion.

**High School Principal Report**

Mr. Tony Butturini reported as follows: 1. Wanda Mueller received a Grant from the WI Beef Council to help purchase materials for her classroom. 2. Included in the packets are requests for youth options. 3. Mr. Aalsma has started a club Making A Difference Adventures Club. There were 40 kids who showed interest in this club. 4. Mr. Sturtz is offering an adult CPR course so far has 18 people registered. 5. Mr. Jaszewski & Mr. Schuh are going to have open shop nights. 6. Mrs. Thomas is doing an Above and Beyond news article in the Brillion News for students who go above and beyond outside of academics and sports. 7. Fall Sports Banquet will be on Tuesday, October 30, 2012, in the high school gym. This year there will be a new award, the Panther Award. This is for someone who had put great effort into the team but wasn’t necessarily the best player on the team.

**II. Public Input**

Dan Sonnenberg spoke about how the 1<sup>st</sup> graders painted three fire hydrants in town. Darlene Propson spoke about the Reedsville Alumni Association. Margaret Reichert spoke about the Board Minutes. Harry Struther spoke about wages and statistics & incorrect publication in Brillion News. Joe Schmatz spoke about the changes to the minutes. Jerold Korinek spoke about the shop classes being offered.

**III. Reports**

**A. District Administrator**

Mr. Dennis Raabe reported as follows: 1. Our band will be performing at the Two Rivers Holiday Parade. Please make sure to go out and support them. 2. Last year at this time we needed to short term borrow \$850,000. This school year we will not need to do the same.

**B. Elem/MS Principal**

Mr. Pat Popp reported as follows: 1. School Garden was a great success due to the efforts of Mrs. Nate & Mrs. Geiger. 2. Mrs. Gulley &

Mrs. Brunner put together the scholastic summer reading challenge, which is a summer reading program to keep the kids reading all summer long. 3. Mrs. Spatchek & Mrs. Butturini have trained the elementary staff on the use of the Smart Boards. 4. Get Up & Move was held for the seventh year, with many new activities showcased. There was a great turn out and a great response from those who attended. 5. Middle school volleyball had a great season and did a great job representing our school. 6. A Hansen fundraiser was held and was a huge success resulting in profits of \$8,815. With these profits the hope is to purchase Ipad’s with protective cases and another Smartboard.

**C. School Psychologist/Supervisor of Special Education**

Dr. Wurm reported as follows: 1. They are working on the Self Assessments for the Special Ed at this time. 2. Child Find Activity was completed. This is the first time we have done it in the fall. Typically this has only been done in the spring. It went well, and they were able to help with some early intervention ideas. 3. Three of our teachers were sent to NVC training through a grant we received. 4. WKCE testing will start next week on Tuesday and run through November 8. 5. Today the school report cards were released. These numbers are a weighted average. Elementary received an 82.2%, Middle School an 76.3% and High School an 71.8%. 6. Update on RTI & PBIS.

D. Myron Genrich - Maintenance Supervisor provided WPS and Integrys handouts. We have been able to make some slight changes which have helped in providing some energy savings.

**D. Board Members**

Todd Cavanaugh asked if the Fall Sports Banquet would be advertised at all so other members of the community could also attend. John Ebert congratulated everyone on all the good things that are happening around the district.

Cory Kiekhaefer seconded. The motion carried. All in favor.

C. Jeff Deprez made a motion to refinance the Pension Liability loan with Denmark State Bank. Andrew Maertz seconded. All in favor.

November 5, 2012
