Memorial Day—Remembering Those Who Have Served!

American Legion Auxiliary members of the Gosz/ Novak Unit 199 of Reedsville understand the sacrifice our Armed Forces have made to preserve freedom and to honor past and current service members. Members of the Gosz/Novak Unit #199 will be wearing a red Memorial Poppy, as a symbol of price of war and the sacrifice of millions, as a sign of their appreciation this Memorial Day weekend.

The 900,000 members of the American Legion Auxiliary, the world's largest women's patriotic service organization, are asking everyone to wear a Poppy on Memorial Day weekend.

"Wear it in honor of the millions of Americans who have willingly served our nation, all too many of whom made the ultimate sacrifice." said Jane Kalies, Auxiliary President, of the Gosz/Novak Unit #199 Reedsville.

The Poppy also honors Wisconsin's disabled veterans at the Zablocki VA Medical Center in Milwaukee who make the red crepe paper Poppy. Wisconsin's Red Poppies provide financial and therapeutic benefits to these veterans, as well as the thousands of veterans and their families who benefit from the donations collected from the distribution of the Auxiliary Poppy.

In the battlefields of Belgium during World War I, poppies grew wild amid the ravages of war. The overturned soils of battle enabled the poppy seeds to be covered, allowing them to grow and forever serve as a reminder of the bloodshed of war.

Each year the Gosz/Novak Auxiliary Unit chooses a Poppy Princess from their Junior Members. This year the Poppy Princess is, Belinda Stelzer, daughter of Stacey and Larry Stelzer of rural Whitelaw, she is the grand daughter of Riney and Joan Grimm of Reedsville.

Board of Review: The Village of Reedsville will hold its first meeting on May 14, 2013 from 2:00 PM to 4:00 PM, in the hall at the Reedsville Municipal Building, 217 Menasha Street, Reedsville, WI. Please contact the Clerk/Treasurer at 754-4371 for the procedural requirements if you want to appear before the Board.

Bicycle Registration: All bicycles must be registered. To obtain the license, flag down a Village Police Officer. A \$2.00 fee covers a one-time registration.

Curfew: Any person under the age of 18 unaccompanied by a parent or legal guardian may not be out and about between 11:00 PM - 6:00 AM Sunday through Thursday and 12:00 PM - 6:00 AM Friday and Saturday.

Vehicle Nuisance: It is illegal for any partially dismantled, non operating, wrecked, junked, unregistered or discarded vehicles to be placed or stored on any public or private property within the Village limits for a period of longer than five (5) days, unless said vehicles are stored within an enclosed building. This ordinance does not apply to property zoned for the sale or repair of vehicles. Having a vehicle behind your garage or under a tarp does not meet the requirement of an enclosed building.

Open Burning/Fire Pits: Controlled burning must be located off the public street pavement or street gutter, must be at least fifteen (15') from any lot line and may not be less than fifteen feet (15') from any building. Only clean wood may be used in fire pits and flames cannot extend more than two feet (2') above the pit. All fires must be monitored by a responsible person until the fire has extinguished itself completely. Persons utilizing and maintaining outdoor fires shall be responsible for any liability resulting from any damage caused by their fire.

Pool Owners: You must fill out the Swimming Pool Discount Application to qualify for the swimming pool discount. No other form of submittal will be accepted. This form can be found on the Reedsville website www.reedsville.org or picked up at the Reedsville Municipal Building Lobby.

Dogs Or Cats: It shall be unlawful to own, harbor, shelter, or keep any dog or cat which runs at large within the limits of the Village. A dog or cat shall be deemed to be running at large when it is on any public street, alley, parks, or other grounds of the Village or any other premises in the Village other than the premises of its owner, his servant, agent or a member of his family of suitable age and discretion unless it is on a durable leash no longer than eight feet (8') or the dog or cat must be under control and within eight feet (8') of its owner, his servant, agent or a member of his family of suitable age and discretion at all times when off the premises of its owner.

Dogs Or Cats: It shall be unlawful for any person owning or in control of a dog or cat to allow or permit such animal to defecate on any private or public property owned by another unless such person shall remove all feces so deposited by such animal. Violation shall be punishable by a forfeiture of not less than twenty dollars (\$20.00) nor more than two hundred dollars (\$200.00).

Vitamin B1 (Thiamine)

Converts carbohydrates eaten into a usable form of energy

If you are active or eat lots of carbs, you need more B1

**SIGNS ASSOCIATED WITH SHORTAGES OF VITAMIN B1
(THIAMINE)**

Poor short-term memory, confusion

Muscular weakness

Apathy

Irritability

Diuretics are a class of pharmaceuticals that increase the amount of urine produced. Because diuretics increase the amount of urine produced, they also deplete the body of many elements. They also cause a depletion of certain vitamins. These medications may deplete zinc, calcium, magnesium, potassium, vitamin B1, vitamin B6, vitamin C, folic acid, co-enzyme Q10 and phosphate.

The class of medications known as anticonvulsants (seizure medications) are quite commonly utilized for seizure disorders (such as epilepsy) and for other indications. Since they have such a pronounced effect on the nervous system, they are also often prescribed for other indications besides seizures--such as sleep or continuous pain. Besides these effects, there is also evidence that these drugs can cause nutrient depletion, which can then bring on other problems not always associated with the medication.

B-vitamins are extremely important to our nervous systems, so it is not surprising that these medications have one of the largest impacts on our B-vitamin stores.

Understanding Gout

Most people have heard of gout, but may not have a good understanding of what it is.

Gout is actually a complex type of arthritis.

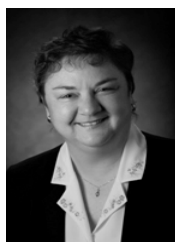
Gout is most often caused by too much uric acid in the blood. But, you can also have normal uric levels and still develop gout. This condition is characterized by sudden, severe attacks of pain, redness and tenderness in joints, often in the joint at the base of the big toe. Gout can impact anyone and most any joint.

Men are more likely to get gout, but women are more prone to gout after menopause. An acute attack of gout gives you the sensation that your big toe or other joint is on fire.

Gout occurs when crystals collect in your joint, causing swelling and the intense pain of a gout attack. Different factors may increase the uric acid level in the body.

The good news is that gout is a treatable condition. There are a few medications that will quickly reduce the pain and swelling.

To prevent future attacks, discuss medication options with your health care provider. Paying attention to your diet can help. Control your weight and get the nutrients you need. Avoid excess amounts of meat, seafood and alcohol.

The regular meeting of the Reedsville Board of Education was called to order at 6:28 P.M. by Board President John Ebert. I. Opening

A. The agenda was approved as printed. Approval of removing minutes out of the consensus agenda.
