Vigilant screening leads the fight against breast cancer

Most women are aware that early detection of breast cancer can save lives through regular mammography screenings and clinical breast exams. Women should consult with their health care provider to discuss their individual risk factors and to develop a personalized schedule for breast cancer screenings. Those at increased risk (women with a family history, genetic tendency, past breast cancer) may benefit from starting mammography screenings earlier and more often or having additional tests such as breast ultrasounds or MRIs. For women at "average" risk, most national guidelines recommend:

- Yearly mammograms starting at age 40 and continuing for as long as a woman remains in good health.
- Clinical breast exams every three years for women in their 20s and 30s and every year for women age 40 and older.
- Women should report any breast changes promptly to their health care provider.
- Monthly breast self-exams are recommended for women, starting in their 20s. Women are more likely to notice a change in their own breasts by doing monthly exams, versus only having them checked at an annual exam.

Increased mammography screenings and improved treatment options have greatly improved the long-term outlook for breast cancer survivors. Early detection of breast cancer saves lives — through a three-pronged approach that includes regular self-exams, mammography screening and clinical breast exams. Schedule your mammogram today!

The Reedsville Fire Department encourages all residents to sign up for the CodeRED program. It allows us to get a message to a certain area in a very short time.

Manitowoc County has contracted with Emergency Communications Network to license its CodeRED high-speed notification system. The CodeRED system provides county officials the ability to quickly deliver messages to targeted areas or the entire county.

Nancy H. Crowley, Emergency Management Director, cautioned that such systems are only as good as the telephone number database supporting them. "If your phone number is not in the database, you will not be called." One of the reasons the CodeRED system was selected is it gives individuals and businesses the ability to add their own phone numbers directly into the system's database, this is an extremely important feature.

"No one should automatically assume his or her phone number is included," Crowley said urging all individuals and businesses to log onto the Manitowoc County website, www.manitowoc-county.com and click on the CodeRED logo in the upper right hand corner of the page which will take you to the "CodeRED Community Notification Enrollment" page. Those without Internet access may call the Manitowoc County Emergency Management Office, 683-4207 to supply their information over the phone. Required information includes first and last name, street address (physical address, no P.O. boxes), city, state, zip code, and primary phone number, additional phone numbers can be entered as well.

All businesses should register, as well as all individuals who have unlisted phone numbers, who have changed their phone number or address within the past year, and those who use a cellular phone or VoIP phone as their primary number.

Crowley explained, "CodeRED allows geographically based delivery, which means street addresses are required to ensure emergency notification calls are received by the proper individuals in a given situation. The system works for cell phones too, but we need to have an associated street address to provide relevant messages."

Crowley stated, "CodeRED gives those who want to be included an easy and secure method for inputting information. The data collected will only be used for emergency notification purposes." Questions should be directed to Nancy Crowley at the Emergency Management Office, 920-683-4207.

Monday July 16, 2012

6:30 p.m.

Minutes

The regular meeting of the Reedsville School Board of Education was called to order at 6:30 p.m. by board President John Ebert.

I. Opening:

A. Roll Call: John Ebert, Todd Cavanaugh, Andrew Maertz, Cory Kiekhaefer and Jeff Deprez were all present. Administrative team members Dennis Raabe, Tony Butturini, Pat Popp and Tracie Wurm were also present. Mr. Raabe announced that proper legal notice of the meeting had been given.

B. Additions/Approval: None

C. Wizard of Oz Presentation by Sue Punt and scholar actors: Ms. Punt talked about the musical and thanked the many businesses and others who had been helpful. They included the following: Mr Z's Balloons, Mad Hatter of Manitowoc, Xavier High School, Reindl's in Menchalville, Roncalli, Reedsville janitorial staff, Reinemann's, Kohls Department Store, Weiting's Funeral Home, Wausau Insurance, Reedsville Buses, Mrs. Propson and Mr. Popp. She also thanked the students who were giving up six weeks of their summer to perform. They included the following: Harper McGoldrick, Heidi Propson, Lexi Schultz, Austin Stokes and Ben Micke. Each student made a short presentation on what they had learned from participating in the musical. The actual presentation will be August 17 and 18th. The public was encouraged to attend.

D. Pledge of Allegiance: The Pledge of Allegiance was led by the students participating in the musical.

Dennis Raabe asked for support for the family of Kordell Dvorachek.

II. Public Input:

President John Ebert read a statement about the purpose of the public input section of the board meeting. President Ebert cautioned people to be respectful when providing input or he would not allow them to continue. The following addressed the board: Stephanie Carriveau, Jerry Korinek, Nancy Eichhorst, and David Eichhorst.

III. Reports:

A. District Administrator: Superintendent Raabe said that he has seen school districts where there is a rift between the educators and the community. As a result, the educators only did the minimum amount to meet their job requirements. The opposite exists in Reedsville and that is why it is such a pleasure to be part of this school system. Dennis handed out a Year End Revenue/Expenditure for Funds 10 and 50. It estimates the year end fund balance increase will be \$503,575, which is double the previous total fund balance. He thanked Tracie Wurm who brought in more grant money than she cost the school district; Tony and Pat made a huge effort to be under budget; Myron also came in significantly under budget. The teachers took a 5% reduction in their budgets. Positions were cut and not replaced last year. Maggie, Bonnie and Becky were also very diligent with expenditures. Dennis reported that taxes will be lowered a little and there will be additional money put into the fund balance this upcoming year. It is anticipated that the mill rate will be

lowered even more in the future. Dennis did state that the school district needs to replace a van for the food service. Dennis also reported on the school relations project designed to build the relationship between Reedsville Public Schools and the local business community. Citizens will be made aware of, and encouraged to patronize local businesses. The NEOLA meetings will need to be rescheduled after summer. This year there will be an OPEB audit.

B. HS Principal- No Report.

C. EL/MS Report: Pat Popp reported that there was a PBIS meeting held today and 95% of the teachers showed up even though it was an unpaid event. He also stated that Sue Punt deserves most of the credit for staging the Wizard of Oz production. He also wanted to thank Tony Butturini for the use of the High School Building.

D. Supervisor of Special Education-No Report.
