The Knights of Columbus Free Throw Championship is sponsored annually with winners progressing through local, district, and state competition.

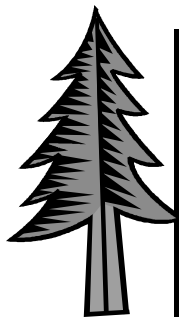
Entry forms will be available at the school the day of the contest.

Notes from the Village Hall

Payment of Property Taxes: Real Estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours. Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. **A receipt will be sent back only if you have included a self-addressed stamped envelop.** All first installment taxes are due by January 31, 2010.

The Village appreciates all taxes be paid by check or money order made payable to the Village of Reedsville

Cat & Dog Licenses are due on or before April 1, 2010.

Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

Clerk/Treasurer's Office Hours: Monday thru Friday, 8:00 AM to 3:00 PM. The Clerk-Treasurer office will be closed at noon on December 31st, and all day January 1st, for the Holidays.

Snow & Ice Removal: The owner or occupant of any lot abutting on a public sidewalk shall clear their sidewalk of snow within twenty-four (24) hours after a snowfall and keep the same free of ice. If such snow or ice is not removed as required herein, the Street Commissioner shall cause the same to be done and the cost thereof assessed against the property owner pursuant to Sec. 66.60(16), WI Stat.

Christmas Tree Pick-up is scheduled for Saturday, January 9, 2010. This is being done by the Reedsville Betterment Club. If you have a question or would like to assist with this, please contact Leroy or Judy Stahl.

Garbage Collection during the holidays will be Saturday, December 26, 2009 and Saturday, January 2, 2010. It will resume its normal collection on Friday, January 8, 2010.

Recycling Pick-Up: January 8th & 22nd

Nomination Papers for Trustee can be picked up at the Clerk/Treasurer's office during normal business hours. The completed forms need to be returned on or before January 5, 2010.

Adopt-A-Hydrant

The winter months bring a special concern to the Reedsville Fire Department. Winter snowfall with the plowing of snow can often hide fire hydrants under a large amount of snow making them difficult to find quickly. In the event of a fire, firefighters have to locate and shovel out fire hydrants before hooking up to them. Precious time is lost.

Please don't let your neighborhood fire hydrant remain "undercover".

The hydrants are normally cleaned out by the Village Street Department, but due to budget and time restraints it can go several days before being cleaned out. We are asking that you help protect yourself and your neighbor by "adopting" the fire hydrant closest to your residence or business and keep it clear of snow.

We need a 3 foot clearance on all sides. When shoveling snow please be aware of vehicle traffic. Do not stand in the street and be careful not to slip and fall out into the roadway.

If you notice a hydrant that needs to be cleaned out, and are unable to "adopt" it, please contact the Village Street Department at 754-4371, so they can take care of it.

Our mission statement is: Encouraging youth to find hope in tomorrow

The farm aims to reach out to area children and teens that need a place to be accepted and find hope.

Children learn responsibility by grooming and feeding the horses, along with other farm chores.

Our purpose is to create a safe and peaceful environment where broken children, horses, and families can find hope. There is no charge for the program. We operate solely on charitable contributions.

Horses tend to mirror the feelings and emotions of their handlers. Because a horse cannot communicate with words, they have to show love and hope through their actions. With that being said, here is an example of how this comes about: A teenage girl that came to be part of the program was totally convinced that out of the seven

horses there was not one that liked her...with those feelings one knows that is how she is feeling about the people in her life, also. On the second or third time that she came, we were brushing Chrissy, a lovely Arabian. We were in the stall conversing and as the girl continued to brush her, unexpectedly Chrissy turned her head and placed it on the girl's chest. That episode brought tears to her eyes as she said, "I think she likes me". Chrissy had been a lonely horse and knew the loneliness of this girl. That is the bonding that occurs between the horse and the child or teenager.
